

Terms of service:

Welcome to Quicker Easier Cheaper.com

This section outlines our relationship with you - the user, describes the service and defines our binding agreement with you.

Eligibility.

Quicker Easier Cheaper.com reserves the right to limit access to our services to certain individuals and businesses at its discretion.

Specifically, we discourage the use of our service by minors.

Minors between the age of 16-18 will require parental consent to be emailed to our legal department to be attached to their profile.

Minors younger than the age of 16 are restricted from using the services of Quicker Easier Cheaper .com under any circumstance.

Only businesses registered in South Africa can currently register their businesses as service providers on the Quicker Easier Cheaper.com platform.

Registration and account safety.

When you register to use Quicker Easier Cheaper.com, you will be asked to provide basic information about yourself or company ("User Data").

Your User Data must be accurate and current at all times. You, the user, are solely responsible for maintaining the security of your account. This means that you must not share your password or allow anyone else access to your account.
